No subletting of tables. No sales to anyone under the age of 18 unless permitted by parent or guardian. No animals allowed other than service animals. Electrical services may come at an additional charge, based on facility. Crocodile has the right to request payment for no show, no call vendors before being allowed to book future tables. Crocodile is not responsible for any lost or stolen items. Crocodile has the discretionary power to remove unacceptable items from sales and display tables.
